



Accommodation Booking & Cancellation Policy

1. Reservation Process:

Hotel reservations should be made in advance (until March 15th) to ensure availability.
Mandatory Arrival and departure dates: 24/04/2024 to 28/04/2024

- A minimum of a 4 days reservation (arrival day 24th and departure day 28th are mandatory) and arrival or departure in less days than the scheduled will incur in an 80euro per person per day penalty.
- Extra day (different from the 24th-28th reservation) charged at 120,00 euro per pax per day.

2. Cancellation Policy:

Minimum 50% of total entry fee should be deposited at our bank no later than March 10th to guarantee the booking.

The remaining payment should be made on arrival.

The organizer will only accept transfers (bank charges will be charged to the remitter. Bank cheque and credit card will not be accepted.

- Cancellations must be made at least April 1st.
- Late cancellations or no-shows may result in NO reimburse.

In special cases such as injury, visas denied, flight cancellation - delay, etc. a 50% be reimbursed.

3. Check-In and Check-Out info:

- Check-in time is 2.00 p. m. - Check-out time is 11:00 a. m.
- Early check-in or late check-out requests are subject to availability and may incur in additional charges.

4. Payment and Billing:

- Minimum 50% of total entry fee must be paid, via bank transfer.

5. Occupancy and Guest Policy:
